

Deals with the organizations and official permissions needed to use any copyrighted work. Old copyrighted material is routinely posted & removed within a few days by hosting services, once they get a take down notice. Digital watermarks are embedded in digital copyrighted materials, as you

may have noticed on your TV channels. Fair use needs clarification, so innocent parties do not rack up lawyer fees. If all of this sounds like the Wild West, it is. Ease of clearance should be the guiding principle, but I don't think you'll get much agreement from all the players with their hands in the cookie jar. Update - As of 2014, Congress is considering updated music royalty laws & distribution to the music creators. The PROs (music royalty collectors) want to get rid of mandatory licensing & the Silicon Valley giants want less expensive royalties & a less heavy handed approach to small music venues. Google lost a case in rate court to the PROs in 2011 & is paying 77K a month to cover copyright fees for YouTube.
